**Top Ten Tips For Wildfire Claimants**

All who've had homes lost or damaged in the fires have our deepest sympathy. We hope this guide provides useful information as you start to rebuild.

1. Obtain a full copy of your homeowner's insurance policy, including your declarations page. Understand your coverage for rebuilding, personal belongings, and living expenses.
2. Be aware of your Additional Living Expense (ALE) limits and manage them carefully for a long rebuilding process.
3. Track all additional expenses and document conversations with your insurer in a "claim diary."
4. Get contractor estimates to compare with your coverage and account for demand surges.
5. Contact the Department of Insurance for assistance at (800) 927-4357.
6. You can rebuild at a different location and still receive full replacement cost benefits.
7. Avoid rushing decisions about contractors or legal representation; take time to evaluate.
8. Public adjusters must be licensed, and fees should only apply to settlements secured after signing a contract.
9. Do not assume underinsurance—verify your limits and consult the Department of Insurance if needed.
10. In a declared disaster, you can cancel public adjuster contracts within five days and verify licenses online.
